1. Completed Application Form
2. Company's Mandate or Mission Statement
3. Photocopy of Certification of Non-Profit Status with Society Title.
(This information is to be displayed on your stall at all times.)
4. Clearly specified dates of Markets that you would like to reserve for your company. Artisan Markets cannot guarantee that these dates will be available. If you are unable to make a market date that you have confirmed, you must notify the market coordinator with 24hr. advanced notice.

MARKET HOURS & LOCATION

Tuesday 2:00pm - 7:00pm / Set-Up at Noon

Vendor Parking is located along the local road, outside of the KJM Customer Parking Area. Do not park in the KJM customer parking. You may drive through this area for set up and tear down only.

Location: KJM Nursery 7226 Blenheim Street, Vancouver South of Marine Drive and just south of West 55th.

* **Please note Artisan Markets does not supply tents, anchors and tables, so please bring your own.** Power is not available at this location.

A 72 Hour Cancellation Policy is mandatory for each market. Your stall area is your responsibility, and the ground beneath your stall must be swept after use.
